<b>Name of project:</b>	Development of a National E-Learning Training programme for NHS Staff undertaking UK Oncology Nursing Service (UKONS) guided 24 Hour Telephone Triage of Oncology /Haematology Patients
<b>Project Overview:</b>	The aim of this Project is for the Parties to work together to support the setting up and development of a National E-Learning Training programme for NHS Staff undertaking UKONS guided 24 Hour Telephone Triage of Oncology and Haematology Patients. This will sustainably increase capability and confidence in patient care in a key part of the patient pathway for NHS cancer workforce, with a goal to enhance cancer patient care and support the safety of patients on cancer therapy.
<b>Project Purpose/ Objectives:</b>	This 15-month Project will improve the standardisation and accessibility of training nationally for NHS staff evaluating the condition of systemic anti-cancer treatment patients. UKONS & BMS recognise the need for appropriate training and education and wish to collaborate on this Project to create freely available, engaging online content for NHS healthcare professionals to upskill on managing patients on and off systemic anti-cancer treatments. Immuno-oncology treatments are known to sometimes have late-effects on patients and therefore, the recognition and appropriate care for these patients within the pathway and system is essential.
